Amendment to Burnham Sailing Club Sailing Instructions Dinghies August 2020

GENERAL

This amendment to the Burnham Sailing Club Sailing Instructions 2020 (the "SIs") relates to the resumption of Club racing following the partial lifting of Covid-19 lockdown and the guidance published by the RYA and Government rulings and advice. It amends or supplements the SIs. The numbers refer to paragraphs of the SIs. Except where amended or supplemented by this amendment the Burnham Sailing Club SIs (available on website) remain in effect.

Crews must either consist entirely of a single household unit or otherwise at all times comply with Government social distancing guidelines as supplemented by the RYA guidelines. (As in newsletter, but see end of this document for more detail)

Throughout this, competitors and shoreside help are reminded that social distancing rules apply and we ask that you are mindful ashore of all regulations and advice.

CHANGES TO SAILING INSTRUCTIONS

SI 1.2 is removed during this phase of unlocking from Covid.

SI 2.1 Notices to Competitors will be posted on the Club website and/or broadcast by the Race Officer on VHF Channel 37 and relayed afloat.

SI 3.1 The Race Officer may change the SIs when needed in response to the current situation. If near the start of a race the L flag will fly and relayed verbally.

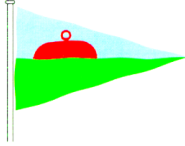

SI 14.1 Please inform the Race Officer as soon as possible on VHF Channel 37 or via support vessel. The time limit for posting is lifted. The protestor must inform the protestee as soon as possible after the incident as in RRS. All efforts to resolve through arbitration must be made, full hearings will be via Zoom or similar as soon as practicable after the race. This almost certainly will not be the same day.

SI 15.2 4 races 1 discard

19.1 is currently removed.

20.1 is amended to include the following supplement:

“Participants should make their own decision about whether to race in the current circumstances and those from different households are responsible for maintaining social distancing in accordance with Government and RYA guidelines. The Burnham Sailing Club nor the PRO is responsible for enforcing social distancing measures on the water between people sailing in the same boat.

We ask that you read our covid 19 guidelines alongside the SIs ad this amendment.
